INFORMATION FOR BIDDERS

The Saudi Arabian Oil Company (Saudi Aramco) hereby solicits of Interest for the work described below. A copy of contractor's Saudi Arab Government commercial registration certificate or ministerial license permitting contractor to perform the type of work to be accomplished under any resulting subject contract(s) (work categories) must be updated in the Electronic Contracting Network (ECN) prior to any contract award.

Subject: Contractor will be responsible for purchasing, loading, transporting Steel Pipes and Carbon Steel Materials from Saudi Aramco Work Sites throughout Kingdom of Saudi Arabia. This includes providing all supervision, manpower, equipment, portable scales and vehicle necessary for the performance of the work.

In addition, Contractor will be required to offload and segregate shipments that contain steel pipes and carbon steel materials in Saudi Aramco Reclamation yards located in Juaymah and Shedgum. This will include providing manpower and equipment, which will be stationed at these locations during all working hours.

Contractor shall be invoiced for purchased materials based on the price of a global commodity index.

SAUDI ARAMCO will not Guarantee any minimum quantity of material to be available for purchase.

Saudi Aramco plans to develop a bid slate for a future procurement for the **SALE OF CARBON STEEL MATERIALS** package.

Prequalification Requirements:

Interested contractors will receive afterwards a Prequalification Package were they can demonstrate full and verifiable contract experience and capabilities in the subject type of work and will be requested to complete the related prequalification questionnaire which will be made available in Saudi Aramco the Electronic Contracting Network (ECN) Website and where the Contractor will submit all required forms and information in using Adobe Acrobat (Acrobat Writer for text and Acrobat Distiller for graphics) and one (1) hardcopy.

The required prequalification softcopy must be password protected by the contractor, to prevent inadvertent alteration, and Uploaded in Electronic Contracting Network (ECN)

To be considered, contractor must have sufficient specialized experience in this type of work category and adequate numbers of qualified manpower and equipment.

A Saudi Aramco Prequalification Evaluation Team will evaluate all submittals in accordance with the applicable evaluation criteria. This will include verification of contractor information and possible site visits to contractor work sites and equipment yards. Contractors that are in Saudi Aramco

judgement prequalified and suitable for the work will be so notified and will be included in a future Bid Slate. Contractors, who do not receive such notification, may request a formal debriefing in accordance with Saudi Aramco Contracting Department standard procedures.

The announcement and prequalification documents shall not be construed to form part of any contract that may be subsequently awarded by Saudi Aramco. Contractors shall furnish the information following the Prequalification Questionnaire format; otherwise, the responses received shall be considered as non-conforming and may result in disqualification.
